When using the unit, please observe the following safety precautions:



- Don't switch the unit on or off, inserting or pulling the power cable.

- If some burning smell or smoke is coming out from the unit, immediately power off the unit from the supply, open the window and call the Service Center or qualified technician.
- Assure adequate air change in the room where the unit is installed, if any ga combusting appliances.





### Timer button

Press "TIMER" button, the time of TIMER timer off in turn sets as 1 hour, 2 hours, 4 hours, 8 hours and off, respectively.



## Sleep button

Press "SLEEP" button SLEEP to turn on/off sleeping function.

> For sleeping mode, the light of sleeping mode lights.



## Ion button

Press "ION" button to turn on/off anion function.

Filter When cleaning filter light flashes it reminds you that you need to clean filters. After the cleaning, press "ION" button for 3 seconds. the timer resets from the beginning.

Press "FAN" and "TIMER" buttons at the


same time for one second, then turn on lock function. The "LOCK" light illuminates. There will be no reaction when press other keys. Press the buttons again, turn off lock function.



# Operation

## Place correctly

In ordor to achieve better purification effect and avoid affecting communication by shielding effect of metal, make sure that keep the machine 30 centimeters away from walls, furnitures and so on and at least 50 centimeters away from metals/electrical appliances.

## Cleaning/Replacement of filter component

Clean filter components when cleaning filter light flashes.

Clean filter with cleaners or brushes.

Recomment to replace filter components when filter components is broken or filtering effect is poor .

Press "ION" button for 3 seconds,
the timer resets from the beginning.

## Tips:

Do not clean filter with water.

Recommend to clean filter with small soft brushes or household cleaners.

In the use of a strong smell of cigarettes, barbecue, etc., within a few weeks or months, the filter may produce a smell. Please clean the filter and air filter for 2-5 days. If you still can not get rid of the smell, please replace the filter.
